ORDER:-

It is pleased to inform you that the Governing Body has approved financial assistance for faculty members for their research articles published in International Conference Proceedings held in India, that are indexed in Web of Science / Scopus, effective from 10.07.2024. The details of the approved incentives are given below:

Criteria:

- 1) Faculty members are eligible for an amount of Rs. 5000/- or the actual expenditure incurred, whichever is less. This assistance will be provided in two parts:

PART 1: -

- a) After presenting a paper at an international conference held in India, the faculty member must submit a claim detailing the expenditure incurred, along with proof of such expenditure. Faculty members are eligible for T.A. and D.A. as per Institute rules but must provide tickets or photocopies of tickets and receipts for registration fees as proof of expenditure. However, no proof is required for claiming D.A.
- b) The actual expenditure incurred in the above forms, subject to a maximum of Rs. 3,000/-, will be sanctioned to the faculty member for paper presentations at international conferences held in India.

PART-2

- a) Upon submission of Web of Science / Scopus indexed conference proceedings, along with the faculty member's profile on Scopus or Web of Science, an amount of Rs. 2000/- will be sanctioned.
- 2) A faculty member can avail of such financial assistance from the university for up to two conferences in a calendar year
 - 3) If a faculty member presents papers more than twice in any calendar year, financial assistance cannot be extended for those additional presentations. However, half of the period of absence for all such paper presentations will be treated as on duty.
 - 4) The above said amount can be claimed by the First author or Corresponding author from the parent University.
