Agenda Item No. BoS/2025/CSE(AI)/2.2: To discuss and finalize the course structure and syllabus for II-B.Tech. Under the AU-24 Regulations

Resolution: BoS approved Second-Year B.Tech. Course Structure and Syllabi under AU24 Regulations for Artificial Intelligence and Machine Learning department

The Board of Studies (BoS) convened to review, discuss, and finalize the proposed course structure and syllabus for the II-B.Tech. program under the AU-24 Regulations. The board conducted a detailed evaluation of the curriculum, with particular focus on academic progression, relevance to current industry needs, and alignment with program outcomes.

During the discussion, Dr. N. Sreenath, Subject Expert from Pondicherry Engineering College, recommended that the course "Software Engineering" be included in the III B. Tech I Semester curriculum. The need of the subject "Software Engineering" is recommended by the expert Dr.B. Srinivasa Rao from central university Hyderabad for the understanding life cycle of the project in the real time application. With this modification, the Board unanimously approved the revised course structure and syllabus for II-B. Tech. Under the AU-24 Regulations.

The Course Structure and Syllabus for II-B.Tech is attached in the Annexure-II
