During the discussion,

Mr. G Varun Kumar Reddy, Industry Representative Member, recommended that each **Course Outcome (CO)** statement should be associated with **only one Bloom's Taxonomy level**, rather than multiple levels in a single statement. This, he noted, would ensure clarity, precision, and ease of assessment in outcome-based education practices.

The Board accepted this valuable suggestion and **revised the CO statements accordingly**, ensuring that each CO is now clearly aligned with a **single, appropriate cognitive level** of Bloom's Taxonomy.

Following the modification, the Board of Studies unanimously **approved the PEOs, PSOs, and the revised COs**, and recommended their implementation from the academic year 2025–26.
